Negotiations Extended for an Agreed Order

Negotiations for an Agreed Order began September 17, 2010 between Ecology and J.R. Simplot. It was expected negotiations would be completed in sixty days; however, an extension has been requested and granted for an additional sixty days.

Simplot owns property at 1800 First Street. Two water supply wells in the West Warden area were found to contain Ethylene dibromide (EDB) contamination. The levels of EDB in these two wells exceed drinking water standards.

Five monitoring wells were installed in West Warden to determine the extent of the groundwater contamination. Only one monitoring well showed EDB. This well was located on Simplot's property at 1800 First Street. Soil sampling in this area also showed elevated levels of EDB on the Simplot property.

The Agreed Order requires Simplot to conduct a Remedial Investigation and Feasibility Study at the Warden City Supply Wells 4 & 5 Site. The Order formalizes the agreement between Ecology and Simplot to further assess contamination and the need for cleanup actions at the site.

The purpose of the Remedial Investigation is to provide additional information about past and current site conditions. More information will be gathered to determine the nature and extent of contamination in groundwater at the site. The purpose of the Feasibility Study is to evaluate cleanup options.

Sediment Investigation Report Available

As part of Governor Gregoire's Puget Sound Initiative, several areas in the Sound have been identified as high priority cleanup areas for the Ecology's Toxics Cleanup Program. Early actions in these areas will contribute significantly to the restoration of Puget Sound. Oakland Bay is one of these early action areas and this investigation is being funded through the Puget Sound Initiative. Ecology chose Oakland Bay because Shelton Harbor has a history of heavy industrial use and previous studies have provided evidence of contamination. In addition, Oakland Bay is one of the most productive shellfish growing areas in the country. In 2008, Ecology's Toxics Cleanup Program collected sediment samples to investigate the health of the sediments in Oakland Bay. Ecology has summarized the results of the study in the Sediment Investigation Report, which is now available for public review and comment.

Negotiations for an Agreed Order

Negotiations for an agreed order began October 18, 2010 between Ecology and the City of Walla Walla. In 2001, the City found contaminants known as volatile organic compounds and inorganic contaminants in groundwater at the landfill. Later testing connected contaminants to landfill activities. The contaminants were at concentrations above background levels and groundwater protection standards.

The agreed order will require the City to conduct a remedial investigation, feasibility study and interim actions at the Sudbury Road Landfill. The order formalizes the agreement between Ecology and the City of Walla Walla to assess contamination and the need for cleanup at the site.

A remedial investigation will provide information about past and current site conditions and assess the nature and extent of contamination in groundwater. The feasibility study will assess cleanup options. Interim actions will involve closure of one section of the landfill and adjustments to stormwater controls in another section.

Draft Guidance for Remediation of Petroleum Contaminated Sites Now Available for Review

Ecology recently completed a draft guidance document for remediation of petroleum contaminated sites. The draft document addresses issues and questions on the requirements for investigating and cleaning up petroleum contaminated sites under the current

Model Toxics Control Act (MTCA) Cleanup Regulation. The draft guidance document is now available for review on the Ecology web site under "Policies and Guidance." http://www.ecy.wa.gov/programs/tcp/policies/pol_main.html

This draft guidance is intended to update and replace previous guidance issued in November, 1995 (Ecology publication 91-30). While it won't answer every question that comes up at petroleum contaminated sites, we think it will help considerably. Ecology will accept comments on the draft guidance through March 18, 2011. We will review all comments and then make appropriate changes before finalizing the document next year.

This draft guidance makes a number of major changes from that earlier guidance. These changes were made in response to implementation questions that people have raised as they investigate and cleanup petroleum releases.

- We increased the scope of the guidance to address all types of petroleum contaminated sites and media, not just releases from underground storage tanks to soils.
- The updates reflect changes in regulations since the 1995 guidance was published.
- The updated guidance provides more information on release reporting, site characterization, establishing cleanup levels, and measuring compliance with cleanup levels.
- Permit-related information has been updated.
- The updated guidance includes new guidelines regarding the re-use of petroleum contaminated soil.

GLOSSARY

Agreed Order - A legal agreement with Ecology to make sure the cleanup meets the standards of Washington State's cleanup law, the Model Toxics Control Act (MTCA).

Cleanup Action Plan (CAP) - A document that describes the selected cleanup method(s) and specifies cleanup standards and other requirements. It is based on information and technical analyses generated during the RI/FS and consideration of public comments and community concerns. A draft of the CAP (DCAP) is made available for public review and comment before finalizing.

Comment Period - A time period during which the public can review and comment on various documents and Ecology or EPA actions. For example, a comment period is provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans. Also, a comment period is held to allow community members to review and comment on draft feasibility studies.

Consent Decree - A formal legal agreement that is filed with a court. It describes studies and/or cleanup work to be done at a site and the terms under which that work is to be done.

Engineering Design Report - Engineering design reports outline the specific details for implementation and operation of the first phase of the cleanup actions.

ERTS - Environmental Response Tracking System

Five Year Periodic Review - A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment.

Hazardous Sites List - A statewide list of contaminated properties. Ecology may remove a site from the list only after determining that all remedial actions except confirmational monitoring have been completed and compliance with the cleanup standards has been achieved at the site, or the listing was erroneous.

Independent Cleanup Action - Any remedial action without department oversight or approval and not under an order or decree

LUST - Leaking Underground Storage Tank

NFA - No Further Action

PSI - Puget Sound Initiative

Publication Participation Plan - Outlines and describes the tools Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

RCW - Revised Code of Washington

Remedial Action - Construction work done to clean up a contaminated site.

Remedial Investigation/Feasibility Study - Two distinct but related studies. They are usually performed at the same time, and together referred to as the "RI/FS."

Responsiveness Summary - A summary of oral and/or written public comments received by Ecology during a comment period on key documents, and Ecology's responses to those comments.

RI/FS - See Remedial Investigation/Feasibility Study

SEPA - State Environmental Policy Act

SHA, Site Hazard Assessment - An assessment to gather information about a site to confirm whether a release of hazardous substances has occurred and to enable Ecology to evaluate the relative potential hazard posed by the release.

UST - Underground Storage Tank

UXO - Unexploded Ordnance

VCP - Voluntary Cleanup Program

Voluntary Cleanup Program (VCP) - The VCP is one of several options for cleaning up a hazardous waste site under the state's cleanup law. Under this option, property owners may perform a cleanup independently and request services from Ecology for a fee.

WAC - Washington Administrative Code

WARM, Washington Ranking Method - The method used to rank sites placed on the Hazardous Sites List
